- 6. Discussion of the recruitment and exam process for Director, Classified Personnel. Babbitt detailed the recruitment process and timeline for Director, Classified Personnel. He expressed his appreciation to Human Resources Specialists, Tina Cano and Katie Kenley for their hard work on the recruitment. Ridenour asked what the criteria was for the screening of the applications. Babbitt advised that Rick Labib-Wood, recruitment consultant, and Cano's screening for minimum qualifications was rigorous and appropriate. Ridenour and Babbitt discussed panel members and possible changes. Ridenour requested three current Directors on the technical panel. Ridenour advised she would prefer to conduct the hiring interviews in person versus Zoom. She expressed her concerns with the designated scoring method as she prefered scoring each panel separately instead of a combined total. Commissioner Martinson advised he is pleased with the diversity of panel members chosen for each panel. Babbitt advised there will be sufficient objectivity with the panel members and questions asked in order to determine candidates who are qualified technically. The commissioners discussed the logistics of inperson interviews versus Zoom.
