

Dear ESS Families,

We would like to extend a huge "thank you!" to all of our families for your flexibility, patience and support as we continue to adapt to the ever-changing world around us. We are excited to announce that La Mesa-Spring Valley Schools will be able to continue services for students during hybrid learning, beginning the week of October 12th, 2020.

Students who attend school will be able to access care during hybrid learning for three full days (the non-school days) and two after school care days (the in-person school session days). Students will attend full day care at hub sites, but will receive care after school on their in-person dates at their home school sites (see below for more detailed information). Families that choose 100% distance learning instead of the hybrid learning option will not be eligible to enroll for ESS services due to staffing and scheduling constraints.

At this time, the schedules and fees for families for the hybrid learning ESS model are:

## **5-day ESS program**

(Non-classroom days - 7am-6pm <u>and</u> days your child attends in-person learning - school dismissal until 6pm)

- One child \$135 per week
- Each sibling \$125 per week, per child

## 2-day, after school only, ESS program

(Days child attends in-person learning - school dismissal until 6pm)

• Each child - \$50 per week

All families will need to log in to their Eleyo account at <u>Imsvschools.ce.eleyo.com</u> and register for the schedule they prefer. Registration is scheduled to open on September 21<sup>st</sup>, 2020. <u>Space is limited and families currently enrolled will have priority</u>. If you choose the 2-day, after school only schedule, your child will attend ESS at their school of attendance. For families choosing the 5-day schedule, your child will attend the hub site on distance learning days and their school of attendance on in-person learning days (after school only).
