Surveys

This section provides a description of surveys (i.e., Student, Parent, Teacher) used during the schoolyear, and a summary of results from the survey(s).

Fletcher Hill's comprehensive needs assessment included the solicitation of input and feedback from our educational partners (parents, teachers, staff, etc.). Our 2021-22 Annual Parent Survey was distributed to gather data regarding the climate and safety of the school and to solicit input about the strengths and areas for growth of the many programs and services we offer. Data from these surveys is included throughout our 2022-23 SPSA.

Consultations and connections with our educational partners took place through virtual Zoom meetings, in-person meetings, online surveys, phone conversations, and student home visits (when possible) and allowed us to assess our educational program, academic interventions, social-emotional and behavioral supports, parent engagement, and school connectedness.

As our 2021-22 school year began, our first priority was to ensure the safety of our learning community, technology needs, and to provide food and resources to our families. As such, our first surveys revolved around the basic needs of our students and their families. Once those basic needs were addressed, subsequent surveys were distributed. Additional technology was distributed in the spring based on student needs.

Surveys sent in preparation for or during the 2021-22 school year included (but were not limited to) topics such as :

- Staff/Parent Quarantine Questions/Concerns
- Student Technology Needs
- Student/Family Community Resources Needs
- Staff Technology Needs

Parent data indicated that 96% of families reported that Fletcher Hills provides high-quality instruction and 94% of families feel the school staff treats them with respect and that school staff is helpful. Parent data indicated a desire for more in-person school connections and family events to rebuild the sense of community at Fletcher Hills, post pandemic. Additionally, 93% of parents reported that their child feels welcome at school. Opportunities for growth at Fletcher Hills include 28% of families, who completed the survey, desiring that staff be more welcoming of their suggestions. An additional area for growth is to increase the perception of fair discipline at Fletcher Hills from 79%. Teacher data displayed the desire for more training and direction in the implementation and data analysis of iReady, student data chats, and high quality teaching strategies in the area of reading comprehension of informational text. All educational partners shared comments about the safety needed if COVID cases started to increase.

The Extended School Services (ESS) program is housed on our campus and provides before and after school childcare in an academic and recreational setting. ESS also distributed parent surveys to participating families at our school site. The survey provides a method of monitoring needs and strengths of the program. Results are shared with all ESS employees and action plans are developed and put in place to address growth opportunities.

Our school will continue to solicit input and feedback from our educational partners during the 2022-

23 school year and utilize the data to improve the work that we are doing in support of our students, families, and staff.

Classroom Observations

This section provides a description of types and frequency of classroom observations conducted during the school-year and a summary of findings.

Daily principal Observations:

To monitor daily instructional practices in order to coach teachers, provide targeted feedback and support, and collect evidence on the professional development needs of staff.

Supervisory Classroom Observations:

Formal teacher evaluations, to evaluate teacher's performance as outlined by the labor contract. These are observation cycles that include both formal and informal observations, goal setting with feedback meetings.

District Walks:

To collect district or school-wide evidence of progress in the implementation of the SPSA and principal goals – to build coherence, identify strengths, areas for growth, and next steps for professional learning, student support, and teaching and learning across the system.

Principal Cohort Walks:

To build a common language and understanding of high quality teaching and learning through inquiry and to build a collaborative network that provides feedback and suggestions to the school on a focus area.

Through Professional Learning Communities, teachers analyze both state yearly assessments and district benchmark assessments taken at specific intervals throughout the year. Teachers set goals and modify adopted curriculum and instruction to address students' needs in both classroom instruction and Response to Intervention (RTI) groupings and topics.

Use of data to monitor student progress on curriculum-embedded assessments and modify instruction (EPC)

Teachers use curriculum-embedded unit, weekly, and daily assessments to monitor student progress toward mastering grade level standards. Formative assessments lead to modifications in instruction to meet the needs of students.

Staffing and Professional Development

Status of meeting requirements for highly qualified staff (ESEA)

Staff at our school site meet the requirements for being highly qualified.

Sufficiency of credentialed teachers and teacher professional development (e.g., access to instructional materials training on SBE-adopted instructional materials) (EPC)

All teachers at our school site are properly credentialed.

All teachers will participate in site-based staff development that takes place 1-2 times a month. We believe that building teacher capacity needs to be systematic and collaborative. Professional development is supported with daily interactions with students and staff and with feedback from the principal. Individuals and collaborative teams identify areas of focus based on student need and site priorities which include, but are not limited to: academic vocabulary, reading comprehension of literature and informational text, and mathematical numbers and operations.

Additionally, teachers can participate in district offerings to supplement site professional development. Teachers are currently afforded the opportunity to participate in professional development online, face-to-face, and blended professional development. Professional development courses have included:

Regardless of the learning format, our educators are eager to engage in professional development, and the District is committed to providing them with many tools, strategies, and training to support all learning models.

Alignment of staff development to content standards, assessed student performance, and professional needs (ESEA)

Staff development is provided to teachers and other staff to address the identified needs of our students. Areas of need are identified by student achievement data, stakeholder input, and observed areas of need. Growth and improvement are measured through principal classroom walkthrough data and student performance. Needs assessments and feedback are elicited in conjunction with each professional growth offering. Based on the feedback, professional growth is adjusted to increase effectiveness. The District is intentional about providing a through line of professional learning that targets the professional growth of new teachers, developing teachers, teacher leaders, new administrators, and veteran administrators.

All staff development is focused on:

- Cultural proficiency and educational equity
- Use of local assessments to inform and modify instruction
- California Common Core State Standards (CCSS) in English-Language Arts and Literacy in History-Social Studies, Mathematics, and Science (Next Generation Science Standards-NGSS)
- California English Language Development (ELD) Standards
- Implementation of the 5D Framework for High-Quality Teaching and Learning
- Development of strong PLCs
- Research-based classroom instruction and best practices

Site level professional development includes site learning day presentations and PLC work. Teachers work collaboratively to plan instruction based on essential standards, reflect on lessons, and analyze student work and assessment data, to improve their practice and increase student achievement. Staff development at our school site in the 2022-23 school year will focus on continuing our work around equity, social emotional learning, data analysis, building teacher capacity in student goal setting, and reading comprehension strategies for informational text across all subjects.

Ongoing instructional assistance and support for teachers (e.g., use of content experts and instructional coaches) (EPC)

Site-based professional development, grade-level collaboration, principal observation, and feedback /coaching provide on-going assistance and capacity building for teachers. Response to Intervention support for classroom instruction includes but is not limited to Teachers on Special Assignment, and Special Education support staff.

Teacher collaboration by grade level (kindergarten through grade eight [K–8]) and department (grades nine through twelve) (EPC)

Each grade-level/department at our school has regularly scheduled meetings to collaborate on the analysis of data, lesson design, and the use of instructional strategies and best practices that work to improve student achievement and performance. Each meeting is designed in professional learning community (PLC) format where each member takes a leadership role and an expectation of reflective conversations surround data analysis, program effectiveness, and "moving the needle" toward student success and achievement. Professional learning communities allow for an ongoing process in which educators work collaboratively in recurring cycles of collective inquiry and action research to achieve better results for the students they serve. Professional learning communities operate under the assumption that the key to improved learning for students is continuous job-embedded learning for educators.

Teaching and Learning

Alignment of curriculum, instruction, and materials to content and performance standards (ESEA)

Following the state adoption cycles, the district-provided curriculum materials and instruction are in alignment with the California Content Standards.

Adherence to recommended instructional minutes for reading/language arts and mathematics (K–8) (EPC)

Instructional minutes in all subject areas are monitored by the District. All teachers turn in their classroom schedule to school administration to ensure adherence to the District guidelines.

Lesson pacing schedule (K–8) and master schedule flexibility for sufficient numbers of intervention courses (EPC)

Essential Standards in math and language arts provide a framework for lesson pacing. All students have a copy of each textbook and/or workbook for core curriculum. Student daily schedules are modified to allow for intervention as needed.

Availability of standards-based instructional materials appropriate to all student groups (ESEA)

Each classroom and student has easy access to adopted curriculum assigned to them in all content areas. The adoption of instructional materials process includes a preview to determine that they are appropriate for the student groups for whom they are purchased.

Use of SBE-adopted and standards-aligned instructional materials, including intervention materials, and for high school students, access to standards-aligned core courses (EPC)

All students have State Board of Education adopted materials for their courses, intervention materials (when needed), and access to standards-aligned core courses. Use of materials is monitored by school administration on a daily basis.

Opportunity and Equal Educational Access

Services provided by the regular program that enable underperforming students to meet standards (ESEA)

All students receive Common Core standards-based instruction at their appropriate grade level. In classrooms, teachers provide additional access to the curriculum through small group instruction. In ELD classes, students are grouped by instructional level, and are assessed and regrouped appropriately. Teachers are required to examine student work samples and meet in subject specific and/or department-level meetings to ensure that students are mastering standards. They also determine student needs, adjust instruction, and plan re-instruction accordingly. Intervention action plans are developed when appropriate. The Student Study Team process is used to identify and monitor students at risk. Interventions are agreed upon and implemented by the classroom teacher in collaboration with the student's family.

Evidence-based educational practices to raise student achievement

Information from state assessments (when available), common assessments, benchmark assessments, needs assessments and surveys, and staff development provide the basis for School Site Council and administrative planning. The use of data to modify and drive instruction with effective evidence-based instructional strategies is our major focus to raise student achievement.

In 2022-23 the following evidence-based educational practices will be employed and focused on to increase and improve student achievement across the campus and across all disciplines: Professional Learning Communities (PLC) Positive Behavior Interventions and Supports (PBIS) Multi-tiered Systems of Support (MTSS) Second Step curriculum for Social-Emotional Learning i-Ready

Parental Engagement

Resources available from family, school, district, and community to assist under-achieving students (ESEA)

Opportunities are provided throughout the year so that families can learn to support their children academically and behaviorally.

To support successful school and family interactions, the district is committed to engaging parents through:

- Parent education workshops provided by district staff and local community agencies
- The use of multiple methods of communication (flyers, phone calls, district/school websites) to promote participation
- The continuance of School Site Councils and English Learner Advisory Committees at each site who send a representative from each site to the district-level parent advisory committees, known as the District Advisory Committee and the District English Learner Advisory Committee
- The distribution of a district-wide parent survey with disaggregated results for each site that can lead to improved results
- The maintenance of a district website with current resources available to parents to support them in working with their children's academic, social, and emotional needs
- Enhancing the awareness and skills of teachers, principals, and staff in reaching out to, communicating with, and working with parents as equal partners

Involvement of parents, community representatives, classroom teachers, other school personnel, and students in secondary schools, in the planning, implementation, and evaluation of ConApp programs (5 California Code of Regulations 3932)

All educational partners (parents, community members, teachers, and other school personnel) have an opportunity to give input on the use of federal funds (as applicable) and the implementation of programs. Specifically, at our school site, the members of School Site Council (SSC) and English Language Advisory Council (ELAC) meet to discuss these matters directly with each other. The District holds monthly stakeholder meetings with parents (DELAC and District Advisory Committee (DAC) where district programs are discussed. In addition, the District holds meetings throughout the year with other stakeholder groups (classified staff, certificated staff, administrative staff) to obtain input about district programs.

Involvement Process for the SPSA and Annual Review and Update

Feedback and input from key educational partner groups are critical for the ongoing success of our students. As part of the planning process for the 2022-23 School Plan for Student Achievement (SPSA), school leadership met with the School Site Council (SSC) and the English Learner Advisory Committee (ELAC). Achievement data (local and state, if available) was shared with these groups and analyzed for trends and patterns of under-performance. That analysis is summarized in the SPSA as the Annual Review for each goal.

School educational partner involvement meeting dates were as follows:

- ELAC/SSC # 4 Meeting, April 27, 2022 at 2:30; ELAC/SSC #5 Meeting, May 18, 2022 at 2:30

- Other meetings where the 2022-23 SPSA goals and metrics were discussed (PTA, etc.): March 1, 2022 at 8:30, April 19, 2022 at 9:00 and May 3, 2022 at 9:00

Feedback from these meetings resulted in the development of goals to be included in the SPSA (Planned Improvement Goals). The District Local Control Accountability Plan (LCAP) was also reviewed to ensure that the Planned Improvement goals of the SPSA aligned with the goals outlined in the District's LCAP.

Resource Inequities

Briefly identify and describe any resource inequities identified as a result of the required needs assessment, as applicable.

Our needs assessment involved a review of our SBAC and dashboard data (where available) as well as our current academic data, parent survey results, chronic attendance rates, and student survey results. When we look at our data compared to our actions and services, we noted the following resource inequities: staffing challenges and lack of funding, specifically to fund a full-time school-based social worker to provide additional support for social emotional needs and chronic absenteeism or a full-time intervention teacher/WIN teacher to support academic needs of all students.

The conclusions based on this data

- 1. Student demographics at Fletcher Hills has remained consistent in all student groups over the three year span, with the largest change being less than 4%.
- **2.** Across the three year span the Hispanic/Latino student group increased 3.8%, which in the highest increase. However, the white student group decreased 3.89%, which is the highest decrease.
- **3.** Fletcher Hills saw enrollment decline 25 students between the 2019-2020 school year and the 2020-2021 school year, with an over all enrollment decline of 30 students.

The conclusions based on this data

- 1. During the 2019-2020 school year there was a high percentage of students Reclassified as Fluent English Proficient (RFEP) at 26.1%, which equates to 6 students.
- **2.** The English Learner population at Fletcher Hills has been between 2.6% and 3.5% over the three year span, which equates to 17-23 students.
- **3.** English learner students who are identified as Fluent English Proficient have remained consistent over the three year span, ranging from 2.6% to 3.5%.

During the 2021-2022 school year teaching and learning were focused on meeting the individual needs of our students through the implementation and monitoring of iReady and classroom assessment data. Based on PLC and school-wide data analysis grade levels developed SMART Goals to target specific skills students were struggling with in both English Language Arts and Math. We utilized an Instructional and Data Support Teacher (IDS) to support teachers and PLC teams in analyzing data and developing appropriate interventions. The IDS teacher co-taught and coached teachers in all grade levels. In addition to Tier 1 interventions, WIN (What I Need) was implemented in all grade levels to target individual student needs.

Our ELA goal was to increase our student performance on iReady from 51% of students at or above grade level, as assessed in May 2021 to 75% of students performing at or above grade level, as assessed in March of 2022. 68% of our students performed at or above grade level as measured by iReady in March 2022. Although we did not reach the target of 75%, we saw an increase of 24%.

Our Math goal was to increase our student performance on iReady from 43% of students at or above grade level, as assessed in May 2021 to 71% of students performing at or above grade level, as assessed in March of 2022. 64% of our students performed at or above grade level as measured by iReady in March 2022. Although we did not reach the target of 71%, we saw an increase of 21%.

Briefly describe any major differences between the intended implementation and/or the budgeted expenditures to implement the strategies/activities to meet the articulated goal.

Our plan to implement WIN pull out intervention groups was delayed due to being able to fill the position with a qualified teacher. Groups were able to start at the end of September and run through mid-June.

Attendance was a barrier for both staff and students due to COVID quarantine protocols. At times, students missed multiple days or even weeks of in person instruction. Additionally, staff absences presented the loss of consistent WIN instruction due to staff needing to be reallocated to cover classroom teachers.

Planned Data Days for teachers to analyze student data, collaborate, and plan an instructional response to the data were cancelled due to staffing coverage.

The academic goal for the upcoming SPSA year will be split into two goals; Goal 1 will be ELA and Goal 2 will be math. We plan to begin implementing WIN instruction with the support of the part-time teacher in late August and continue it through early May. We also plan to provide data release days for teachers at least once mid-year.

Based on PLC and school-wide data analysis, grade levels and special education teams developed SMART Goals to target specific skills students were struggling with in both English Language Arts and Math. We utilized an Instructional and Data Support Teacher (IDS) to support teachers in both general education and special education and PLC teams in analyzing data and developing appropriate interventions. The IDS teacher co-taught and coached teachers in all grade levels. In addition to Tier 1 interventions, WIN (What I Need) was implemented in all grade levels to target individual student needs. Our English Learners were clustered by EL proficiency for Designated ELD Instruction, as planned.

Our ELA goal for socioeconomically disadvantaged students was to increase our student performance on iReady from 27% of students at or above grade level, as assessed in May 2021 to 51% of students performing at or above grade level, as assessed in March of 2022. 61% of our socioeconomically disadvantaged students performed at or above grade level as measured by iReady in March 2022. This is an increase of 34%.

Our Math goal for socioeconomically disadvantaged students was to increase our student performance on iReady from 20% of students at or above grade level, as assessed in May 2021 to 35% of students performing at or above grade level, as assessed in March of 2022. 51% of our socioeconomically disadvantaged students performed at or above grade level as measured by iReady in March 2022. This is an increase of 31%.

Our ELA goal for students with disabilities was to increase our student performance on iReady from 13% of students at or above grade level, as assessed in May 2021 to 30% of students performing at or above grade level, as assessed in March of 2022. 27% of our students with disabilities performed at or above grade level as measured by iReady in March 2022. Although we did not reach our goals, this is an increase of 14%.

Our Math goal for students with disabilities was to increase our student performance on iReady from 10% of students at or above grade level, as assessed in May 2021 to 25% of students performing at or above grade level, as assessed in March of 2022. 27% of our students with disabilities performed at or above grade level as measured by iReady in March 2022. This is an increase of 15%.

Briefly describe any major differences between the intended implementation and/or the budgeted expenditures to implement the strategies/activities to meet the articulated goal.

Site Learning Days were focused on equity practices for all student groups, but ELD instruction was not specifically focused on as part of our professional development.

We developed and implemented a site intervention team that meets bi-monthly. This team includes the IDS teacher, school psychologist, SAI teachers, speech pathologist, school social worker, principal, and general education teachers. The team closely monitored and discussed next steps for students needing additional supports.

At Fletcher Hills we continued to implement Character Education programs including PeaceBuilders and monthly character traits. Soaring Falcon Slips were read during daily morning announcements to recognize students for both academic and positive behaviors. Student recognition awards were presented monthly based on the specified character trait. Our school social worker creates weekly SEL lessons for teachers to use with their students. Our school social worker monitored student attendance and communicated with families regularly. The school social worker holds weekly SEL group lessons for students identified by the intervention team. Additionally, the school social worker supports families with referrals to SchooLink, safety and support plans for students, and provides regular parent education opportunities. SST meetings and SART meetings were held as needed to support students. Restorative Practices are utilized regularly with students by all staff.

Overall school attendance rates fell below our baseline of 97% due to required COVID quarantine protocols. Our goal to decrease the percentage of students with chronic absenteeism by 1% was not met. Our chronic absenteeism increased from 5.86% to 19.51% due, at least in part, to required COVID quarantine protocols.

Suspension rates decreased from 0.72% to 0.3%.

Briefly describe any major differences between the intended implementation and/or the budgeted expenditures to implement the strategies/activities to meet the articulated goal.

Attendance awards were discontinued due to increased absences required by COVID quarantine protocols and equity practices. The Probation Officer position was eliminated. Instead, the school social worker and Student Supports department supported truancy intervention and prevention. All other strategies/activities were implemented as planned.

Trainings were provided for ELAC and SSC and were held virtually at the beginning of the school year. PTA, ELAC, and SSC meetings were held virtually as well. School social workers provided parent education opportunities on metal health and SEL topics. Regular parent education opportunities were offered virtually. Weekly parent communications were sent from principal via Blackboard Connect. School website and marquee were updated regularly. Social media platforms were utilized to highlight learning on our campus and student engagement, as well as to promote school and PTA activities.

Highlights from this year's parent survey data include that 96% of parents reported that Fletcher Hills provided high-quality instruction, 94% of parent report that the school staff is helpful and respectful. Additionally, 93% of parents reported that their child feels welcome at school. Opportunities for growth at Fletcher Hills include 28% of families, who completed the survey, desiring that staff be more welcoming of their suggestions. An additional area for growth is to increase the perception of fair discipline at Fletcher Hills from 79%.

Most parent and family events were not held outside of the school day due to COVID restrictions. As case numbers declined, these events returned in the spring of 2022.

- 4. Identify resource inequities, which may include a review of LEA- and school-level budgeting, to be addressed through implementation of the CSI plan (Goal, Identified Need, Expected Annual Measurable Outcomes, Planned Strategies/Activities; and Annual Review and Update, as applicable).

The TSI plan shall:

- 1. Be informed by all state indicators, including student performance against state-determined long-term goals (Goal, Identified Need, Expected Annual Measurable Outcomes, Annual Review and Update, as applicable); and
- Include evidence-based interventions (Planned Strategies/Activities, Annual Review and Update, as applicable). (For resources related to evidence-based interventions, see the U.S. Department of Education's "Using Evidence to Strengthen Education Investments" <u>https://www2.ed.gov/policy/elsec/leg/essa/guidanceuseseinvestment.pdf</u>.)

Additional Targeted Support and Improvement

A school identified for ATSI shall:

 Identify resource inequities, which may include a review of LEA- and school-level budgeting, which will be addressed through implementation of its TSI plan (Goal, Identified Need, Expected Annual Measurable Outcomes, Planned Strategies/Activities, and Annual Review and Update, as applicable).

Single School Districts and Charter Schools Identified for School Improvement

Single school districts (SSDs) or charter schools that are identified for CSI, TSI, or ATSI, shall develop a SPSA that addresses the applicable requirements above as a condition of receiving funds (EC Section 64001[a] as amended by Assembly Bill [AB] 716, effective January 1, 2019).

However, a SSD or a charter school may streamline the process by combining state and federal requirements into one document which may include the local control and accountability plan (LCAP) and all federal planning requirements, provided that the combined plan is able to demonstrate that the legal requirements for each of the plans is met (EC Section 52062[a] as amended by AB 716, effective January 1, 2019).
