- CSEA Update Chapter 419 President, Ahmad Swinton reported:
  Not present
- Personnel Update Director, Classified Personnel, Andrea Rivera reported:
  - The Classification and Compensation study: most managers have provided their input to consultants. Job descriptions with supervisor comments and proposed pay plan are anticipated to be submitted to the Personnel Commission by April 14, 203. Martinson inquired if the consultants are providing good data. Rivera advised will know more once all data is received. There may be some follow up work needed for the study.
  - Paraprofessional and Paraprofessional-Preschool will be opened for application on Monday after spring break. Personnel Commission staff is working through final steps of several clerical recruitments: School Office Manager, School Office Manager – Bilingual, School Office Assistant – Bilingual, Health/Attendance Technician. Pratt questioned if an incentive for clerical positions would benefit the recruitment efforts. Rivera advised the District would need to provide incentive. Rivera stated the Paraprofessional-Preschool recruitment really increased when the position changed from 3.5 to 6.0 hours.
