- 7. Information Items
 - Personnel Update Director, Classified Personnel, Andrea Rivera reported:
 - Recruitment 13th new recruitment for this year including four supervisory positions. Currently 95 vacancies for paraprofessional-special education. Over summer, interviews were centralized, which helped the process. PC has hired over 50+ paras over the summer. Rivera advised approximately 1/3 of paras turnover every year; Rivera expressed her thanks to the PC team for their dedication and hard work.
 - Classification and Compensation Study currently at a standstill. Working with vendor to see if we can get a suitable product to bring to bargaining. Meeting with Steering committee is scheduled for next week.
 - District Update Assistant Superintendent, Human Resources, Dr. Meg Jacobsen reported:
 - Started bargaining for 2023-24 school year and Jacobsen advised they have signed an MOU for paraprofessional Incentive/Retention. They also revisited the MOU for paraprofessional/student teacher for Ed Specialist renewal.
 - Job Fairs are being held every month.
 - Jacobsen advised they are seeing a significant increase in benefits and insurance rates with Kaiser specifically and is working on joint messaging. The annual Insurance and Benefits Fair is coming up October 17th.
 - Class and Comp study Grateful with partnership with CSEA and PC.
 - Jennifer Nerat, current Assistant Superintendent, Business Services for LMSV is resigning and we are working through this transition.
 - TK Expansion TK classes will be at every elementary school.
 - 6th grade Transition is primarily due to this expansion.
 - Most transition is on certificated side.
 - SVA enrollment- 300 students for 23-24. SVA excited to have 6th grade back on campus.
 - PKMS enrollment- Really growing, opened up sixth grade classrooms. Lots of new programs for the 23-24 school year.

- LMAAC- 4th grade will be matriculated up.
- STEAM- Excited to have 6th grade back.
- SVA has a new AVID focus. Staff trained over the summer. All students will have an AVID class. Has CTE partnerships with local high schools.
- Videos have been made for each of the middle schools. Including sixth grade transitions. Communication will start after October break.

• CSEA Update - Chapter 419 President, Ahmad Swinton reported:

- Swinton advised he is excited about MOUs, especially the paraprofessional/student teacher MOU.
- Shared in the disappointment in the results being provided by the consultant conducting our classification and compensation study. A lot of work has been done, so hopefully it's salvageable.
- o Swinton introduced Kyler Miller as new CSEA Labor Representative replacing Daniel Ortiz.
- Advised that John Sullivan was honored at the CSEA Conference this summer. John will also be recognized at the next school board meeting.

- AB1699 Babbitt advised that he attempted to meet with representative Dr. Weber, but was unsuccessful. Rivera says PC is working through several strategies to work through the changes.
