- Personnel Update Director, Classified Personnel, Andrea Rivera reported;
  - Rivera reported that her team has moved through the bulk of the recruitment influx they received as they entered the holiday season. She mentioned that they are still opening recruitments but not at the rate they were in December and early January.
  - Rivera also reported her team is still slowly filling Paraprofessional Special Education vacancies and is working to fill some specialty paraprofessional vacancies in the visually impaired and communication facilitator areas. Rivera mentioned her team is slow moving through the Paraprofessional and Paraprofessional – Preschool recruitment as they have seen a slow applicant flow.
  - Rivera stated that she and Ali Junker, Human Resources Analyst, are back working on the Classification Study project and are currently working through the child nutrition family. This job family requires a considerable amount of rework as the job descriptions are convoluted and essential functions repetitive. She will be bringing a portion of the job family to bargaining next week but will need more time on the other job descriptions before feeling comfortable bringing them forward to recommend changes.
- District Update Assistant Superintendent, Human Resources, Dr. Meg Jacobsen reported:
  - Jacobsen advised that bargaining is next week with CSEA. She is excited to talk about the updated job descriptions.
  - Jacobsen reported the job fair next week on Tuesday will focus on bus drivers and paraprofessionals. She talked about hiring incentives for bus drivers and a paid training program that is working well.
