Involvement Process for the SPSA and Annual Review and Update

Feedback and input from key educational partner groups are critical for the ongoing success of our students. As part of the planning process for the 2026-27 School Plan for Student Achievement (SPSA), school leadership met with the School Site Council (SSC) and the English Learner Advisory Committee (ELAC). Achievement data (local and state, if available) was shared with these groups and analyzed for trends and patterns of under-performance. That analysis is summarized in the SPSA as the Annual Review for each goal.

School educational partner involvement meeting dates were as follows:

- * ELAC #3 Meeting, 1-8-26
- * SSC # 4 Meeting, 4-16-26; SSC #5 Meeting, 5-21-26
- * Staff Meetings where the 2026-27 SPSA goals and metrics were discussed: 2-13-25, 4-24-25, 5-20-25

Feedback from these meetings resulted in the development of goals to be included in the SPSA (Planned Improvement Goals). The district Local Control Accountability Plan (LCAP) was also reviewed to ensure that the Planned Improvement goals of the SPSA aligned with the goals outlined in the district's LCAP.

Comprehensive Needs Assessment Components

California School Dashboard (Dashboard) Indicators

Referring to the California School Dashboard (Dashboard), any state indicator for which overall performance was in the "Red" or "Orange" performance category.

- * In ELA, we do not have any overall groups performing in the red or orange performance category.
- * In Math, we have two student subgroups, Socioeconomically Disadvantaged Students (113 students) and Students with Disabilities (65 students) that performed in the orange performance category.
- * In suspension rates, students in the subgroup of two or more races were in the orange performance band.
- * In chronic absenteeism, English Learners (52 students) were in the red performance category.

Referring to the California School Dashboard (Dashboard), any state indicator for which performance for any student group was two or more performance levels below the "all student" performance.

- * In ELA, all students (237) performed in the blue performance band, increasing scores by 15.1 points and performing 28.4 points above standard. Students with Disabilities group (66 students) was two or more performance levels below "all students" in the yellow performance band. To address this issue we will consider the following: Increase collaboration between Specialized Academic Instructors and general education teachers and implementation of strong Tier 2

interventions within the general education classroom to support specialized academics. Additionally, the Socioeconomically Disadvantaged Students group (111 students) was two or more performance levels below "all students" in the yellow performance band. To address this issue, we will continue school supports to increase attendance and school engagement.

* In Math, all students (238) performed in the green performance category. Socioeconomically Disadvantaged Students (113 students) performed in the orange performance band. To address this issue, we will continue school supports to increase attendance and school engagement. Additionally, Students with Disabilities (65 students) performed in the orange performance band. To address this issue we will consider the following: Increase collaboration between Specialized Academic Instructors and general education teachers and implementation of strong Tier 2 interventions within the general education classroom to support specialized academics.

*In chronic absenteeism, all students (561 students) performed in the yellow category. In chronic absenteeism, English Learners (52 students) were in the red performance category. To address this issue, we will utilize Attendance Recovery, ISA agreements and staff outreach to increase attendance.

*In suspension rates, all students (568) performed in the blue category. Students in the subgroup of two or more races performed in the orange band. To address this issue, school staff will implement restorative practices, such as alternative recess or elementary diversion programs, in lieu of suspension and continue staff and campus attendant check-ins to decrease non desired behaviors.

Other Needs

In addition to Dashboard data, other needs may be identified using locally collected data developed by the LEA to measure pupil outcomes.

Murray Manor chronic absenteeism remains at 14.4% according to the 2025 CA Dashboard. To address this issue we will continue weekly parent messaging about the importance of attendance, weekly attendance grade level competition and student messaging, and outreach phone calls to identify tailored interventions that address specific barriers to regular attendance.

1. Student enrollment maintained around 530 students throughout the 2024/2025 school year.
2. Kindergarten had the lowest enrollment in 2024/2025 school year and 2nd and 3rd grade had the highest enrollment of 88 students each.
3. White (213) and Hispanic (191) were the highest student populations in the 2024/2025 school year.

- English Learner enrollment decreased from 7.6% in the 2023/2024 school year to 6.8% in the 2024/2025 school year.
- 42.3% of English Learners made progress in the 2024/2025 school year which is a 12% decrease from the 2023/2024 school year.
- Fluent English Proficiency rate declined from 4.2% in the 2023/2024 school year to 3.2% in the 2024/2025 school year.

Conclusions based on this data:

1. Students exceeding or meeting standard on CAASPP ELA increased from 58.27% in the 2023/2024 school year to 62.60% in the 2024/2025 school year.
2. Fourth grade students exceeding standard on CAASPP ELA increased by 10.81% from the 2023/2024 school year to the 2024/2025 school year.
3. Third grade students exceeding grade level standard on CAASPP ELA declined by 7% between the 2023/2024 to 2024/2025 school year and fifth grade decreased by 3% between the 2023/2024 and 2024/2025 school year.

Conclusions based on this data:

1. Fifth grade students exceeding or meeting standard on CAASPP Math increased 6.84% from the 2023/2024 school year (40%) and the 2024/2025 school year (46.84%).
2. Third grade students exceeding or meeting standard on CAASPP Math decreased by 7.6% between the 2023/2024 (68.36%) and 2024/2025 (60.76%) school years.
3. Fourth grade students exceeding or meeting standard on CAASPP Math decreased by 2% from 2023/2024 (65.79%) to 2024/2025 (63.85%).

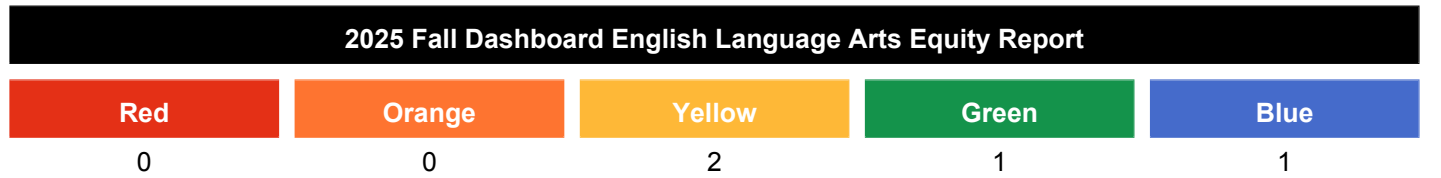

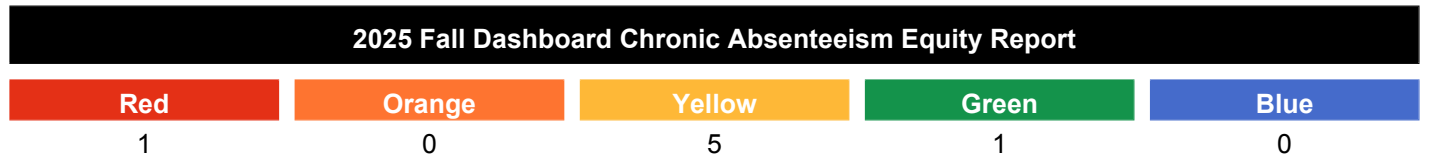

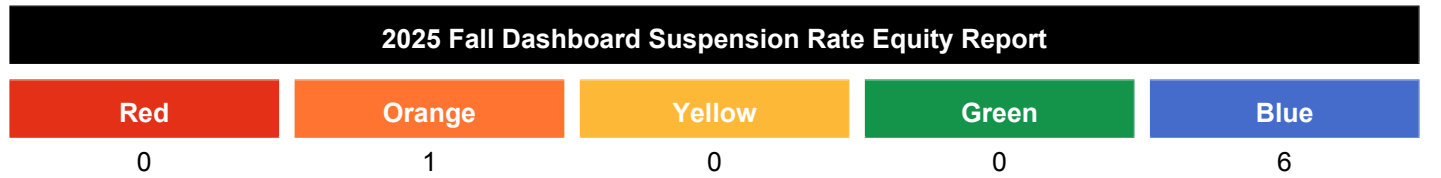

Include an analysis of verifiable state data, consistent with all state priorities as noted in Sections 52060 and 52066, and informed by all indicators described in Section 1111(c)(4)(B) of the federal Every Student Succeeds Act, including pupil performance against state-determined long-term goals. The school may include data voluntarily developed by districts to measure pupil outcomes (described in the Identified Need).
 - b. Be based on academic achievement information about all students in the school, including all groups under §200.13(b)(7) and migratory children as defined in section 1309(2) of the ESEA, relative to the State's academic standards under §200.1 to:
 - i. Help the school understand the subjects and skills for which teaching and learning need to be improved.
 - ii. Identify the specific academic needs of students and groups of students who are not yet achieving the State's academic standards.
 - iii. Assess the needs of the school relative to each of the components of the schoolwide program under §200.28.
 - iv. Develop the comprehensive needs assessment with the participation of individuals who will carry out the schoolwide program plan.
 - v. Document how it conducted the needs assessment, the results it obtained, and the conclusions it drew from those results.
 - B. Identification of the process for evaluating and monitoring the implementation of the SPSA and progress towards accomplishing the goals set forth in the SPSA (described in the Expected Annual Measurable Outcomes and Annual Review and Update).

Requirements for the Plan

- II. The SPSA shall include the following:
 - A. Goals set to improve pupil outcomes, including addressing the needs of student groups as identified through the needs assessment.
 - B. Evidence-based strategies, actions, or services (described in Strategies and Activities)

1. A description of the strategies that the school will be implementing to address school needs, including a description of how such strategies will:
 - a. Provide opportunities for all children including each of the subgroups of students to meet the challenging state academic standards
 - b. Use methods and instructional strategies that:
 - i. Strengthen the academic program in the school,
 - ii. Increase the amount and quality of learning time, and
 - iii. Provide an enriched and accelerated curriculum, which may include programs, activities, and courses necessary to provide a well-rounded education.
 - c. Address the needs of all children in the school, but particularly the needs of those at risk of not meeting the challenging State academic standards, so that all students demonstrate at least proficiency on the State's academic standards through activities which may include:
 - i. Strategies to improve students' skills outside the academic subject areas;
 - ii. Preparation for and awareness of opportunities for postsecondary education and the workforce;
 - iii. Implementation of a schoolwide tiered model to prevent and address problem behavior;
 - iv. Professional development and other activities for teachers, paraprofessionals, and other school personnel to improve instruction and use of data; and
 - v. Strategies for assisting preschool children in the transition from early childhood education programs to local elementary school programs.
- C. Proposed expenditures, based on the projected resource allocation from the governing board or body of the LEA (may include funds allocated via the ConApp, federal funds, and any other state or local funds allocated to the school), to address the findings of the needs assessment consistent with the state priorities, including identifying resource inequities, which may include a review of the LEAs budgeting, it's LCAP, and school-level budgeting, if applicable (described in Proposed Expenditures and Budget Summary).  - 2. Provide sufficient information on which to base effective assistance to those students.
- G. For an elementary school, a description of how the school will assist preschool students in the successful transition from early childhood programs to the school.
- H. A description of how the school will use resources to carry out these components (described in the Proposed Expenditures for Strategies/Activities).
- I. A description of any other activities and objectives as established by the SSC (described in the Strategies/Activities).
